



## TUITION & FEES 2021-2022

Faith Training Christian Academy is supported solely by student tuition and gifts from friends of the Academy. FTCA is administered by two full-time principals and a six-member Church Board.

Tuition is divided into 10 monthly payments (sibling discounts are available). Tuition and other fees for the 2020-2021 school year are as follows:

A \$15.00/month discount will be given for the second child a family enrolls, \$30.00/month discount for the third child, \$45.00/month for the fourth child, etc.

### **\*\*New Student Registration Fee: \$200 per student**

This **non-refundable** fee covers the costs of processing a new student including application process, records, screening, testing, orientation, interview, and billing. This registration fee is refundable should admission be denied.

### **\*\*Student Resource Fee: \$325.00 per student**

This **non-refundable** fee is due for all students by June 1, 2021. This fee covers all textbooks and workbooks, SAT testing, and student insurance. In addition, SRF covers capital improvements including the acquisition and improvement of our building and grounds. *This is an annual fee due every June.*

### **\*\*\*After School Care: \$120.00 per student/month or \$5.00/hr.**

The hours for ASC are Monday-Thursday 3:45-5:30p.m. and Friday 7:30-5:30p.m. If students in any grades have not been picked up by 3:45, they must check in with ASC. **They may not stay unsupervised.** If a student stays on an occasional basis the charge will be \$5/hour or any part of an hour. Our ASC program is provided for FTCA students only.

**Late Fee:** Monthly payments are due and payable on the 1<sup>st</sup> of each month. Tuition, ASC, and bus fee are past due if payment is **received on the 11<sup>th</sup> calendar day or thereafter** and a late payment fee of \$25.00 per student will automatically be assessed. If payment has not been received by the 10<sup>th</sup> of the month, or, if no arrangements have been made with the Business Office, the student(s) affected will be dismissed. There will be a \$30.00 processing fee on any insufficient funds check.
